

WARRANTY

Dear Customer,

First of all, we want to thank you for your decision to buy our products, assuring you that they are carefully tested before shipment, and backed by this warranty.

To avoid any needless inconvenience to our customers, we strongly recommend a close attention to the instructions attached to or furnished with our products, and to the following terms and conditions before seeking guarantee service.

WARRANTY

By this warranty, we guarantee our products to be free from defects in materials and workmanship at the date of original purchase for a period of TWO YEARS from that date, according to the European law.

In unlikely rare event that during the two-year period of this warranty any of our products, properly operated and maintained, proves defective due to faulty materials or workmanship, we will repair or replace the product at our option using new or refurbished components, with no charge for labour or component, under the terms and limitations below.

CLAIM PROCEDURES, REQUIREMENTS AND LIMITATIONS

Guarantee services will be provided only if the original invoice or sales receipt (indicating the date of purchase and model name), with the defective product and a detailed description of the problem, is sent to the following address within the within the indicated two-year period:

This warranty will not apply if the model name or serial number on the product has been altered, deleted, removed or made illegible; or if the cover or base of the package present nicks, dents, bends or any other damage.

This warranty does not cover transport costs or risks associated with transport of the defective product to and from our premises.

This warranty is not liable for any loss and/or damage as a result of any of the following circumstances:

- Periodic maintenance and repair of components, and parts replacement.
- Consumable parts and elements that are expected to require periodic replacement during the lifetime of a product.
- Failure to install or use the product for its normal purpose or in accordance with the care
 instructions attached to it, or in a manner inconsistent with the technical or safety
 regulations or standards in the country where it is installed or used.

- Failure to maintain the product in accordance with our instructions on proper maintenance; or as a result of unauthorized attempts to open, repair or modify the product, or any other cause beyond the range of the intended use.
- Virus infections or use of the product with software not provided with the product or incorrectly installed.
- Use of the product with third-part devices or components. In this sense, *MCT Meb Johnsons Jatto* makes no representations or warranties on behalf of such third parties, and any warranty on such products will be from the supplier or licensor of the product.
- Anything other than defects in materials or workmanship.
- Extended or excessive exposure to sunlight (or ultra-violet radiation) or ionizing radiation, fire, liquids, chemicals, flooding, vibrations, excessive heat or power surges, electrostatic discharges, or excess or incorrect supply or incorrect voltage.
- External forces or impacts.
- Normal wear and tear, including scratches on the outside casing and fading.
- Improper handling or storage.
- Neglect.
- Force majeure.

EXCLUSIONS

MCT - Meb Johnsons Jatto makes no warranties regarding products or accompanying or constituent software quality, accuracy, reliability or fitness for specific purposes. In the case that this exclusion is not permitted or fully permitted by pertinent law or statutes, *MCT - Meb Johnsons Jatto* limits its warranties to the maximum extend permitted by such regulations.

This warranty is exclusive and in lieu of all other warranties, guarantees, agreement and similar obligations of manufacturer or retailer, whether express or implied, including warranties of merchantability, fitness for a specific purpose, or rightful claim of any third party for infringement of trademark or intellectual property rights, all of which are expressly disclaimed by *MCT - Meb Johnsons Jatto*.

We are not liable for any other economic or intangible losses, such as the price paid for the products, or loss of eventual benefits or revenue; or indirect, incidental or consequential loss or damage, such as the loss of enjoyment or use of the product.
